You have been charged with a traffic offense in the Municipal Court of the City of Gulf Shores, Alabama. You have a right to a trial. The date entered on the citation just above the space for your signature is a plea date. You must be in Municipal Court at 203 Clubhouse Drive, Gulf Shores, Alabama, at 3:30 P.M. on the date specified on your citation if you have not taken care of the citation in another manner prior to the Court date. Failure to do so may result in arrest, additional expense and the loss of your driver's license. If you have not been convicted of two or more traffic violations within the past year and are charged with one of the offenses LISTED BELOW and wish to PLEAD GUILTY and pay the Fine and Costs, you may do so by mail or in person in the Clerk's office (203 Clubhouse Drive). (With a Money Order you may use the drop box in the front lobby of the Police Department, 220 Clubhouse Drive.) Your payment must be mailed in time so it will arrive at the Court Clerk's office by the appearance date shown on the citation.

(Note: Some Alabama Driver's License Points assessed as of May 1, 2009, noted in parenthesis after charge. 2Pts. for all other moving violations not marked.)
