January 19, 2022**

The Gulf Shores Beautification Board met on Wednesday, November 17, 2021 in the Council Chambers of City Hall. Kathy Brown called the meeting to order.

Brooke Taylor made a motion to accept the minutes of the November 17, 2021 meeting, seconded by David Mayfield. Motion carried.

Arbor Day: Linda Bender reported that after polling the Board members, the decision was made to hold Arbor Day celebration at Gulf Shores Elementary School. Without much change, the plan used in 2021 will be followed this year.
