2. INSURANCE CERTIFICATE AND ENDORSEMENTS

If automobiles or inflatables will be utilized, the applicant shall obtain a minimum of \$1,000,000 combined single limit coverage per accident, including owned, hired and non-owned automobiles or inflatables. If any alcohol will be served, liquor liability coverage must be obtained and is subject to Alabama's statutory limits. If the applicant has employees, workers' compensation insurance must be obtained and is subject to Alabama's statutory limits. The applicant also agrees to endorse the City of Gulf Shores (City of Gulf Shores, Alabama, Attn: Purchasing Officer, P.O. Box 299, Gulf Shores, AL 36547) as an additional insured on the general liability, auto, and liquor liability policy and to include a copy of each endorsement with the certificate of insurance. Proof of insurance, acceptable to the City, shall be furnished no later than five (5) days preceding the date of the assembly. Failure to provide proof of insurance will automatically revoke permit. Each certificate of insurance shall provide that the insurer must give the City of Gulf Shores at least thirty (30) days' prior written notice of cancellation and termination of the applicant's coverage there under.

I, the applicant, understand that I am responsible to provide all information necessary to meet the conditions and requirements of the application process and that by providing such information it is no guarantee that my proposed event will be issued a permit by the City of Gulf Shores. I further agree to defend, indemnify and hold the City of Gulf Shores harmless from and against all third party claims, demands, liabilities, losses, damages, suits, judgments, costs, expenses (collectively, "Third Party Claims") and reasonable attorney's fees in any manner arising out of or resulting from bodily injury, sickness, disease or death of any person or persons, or damage to or destruction of tangible property, including the loss of use resulting therefrom, or caused by or occurring during the course of performance of any services provided and to meet all department deadlines including submitting proof of proper insurance, a detailed site map, payment of all departmental fees, and details for any contract services required to make the proposed event safe and successful. 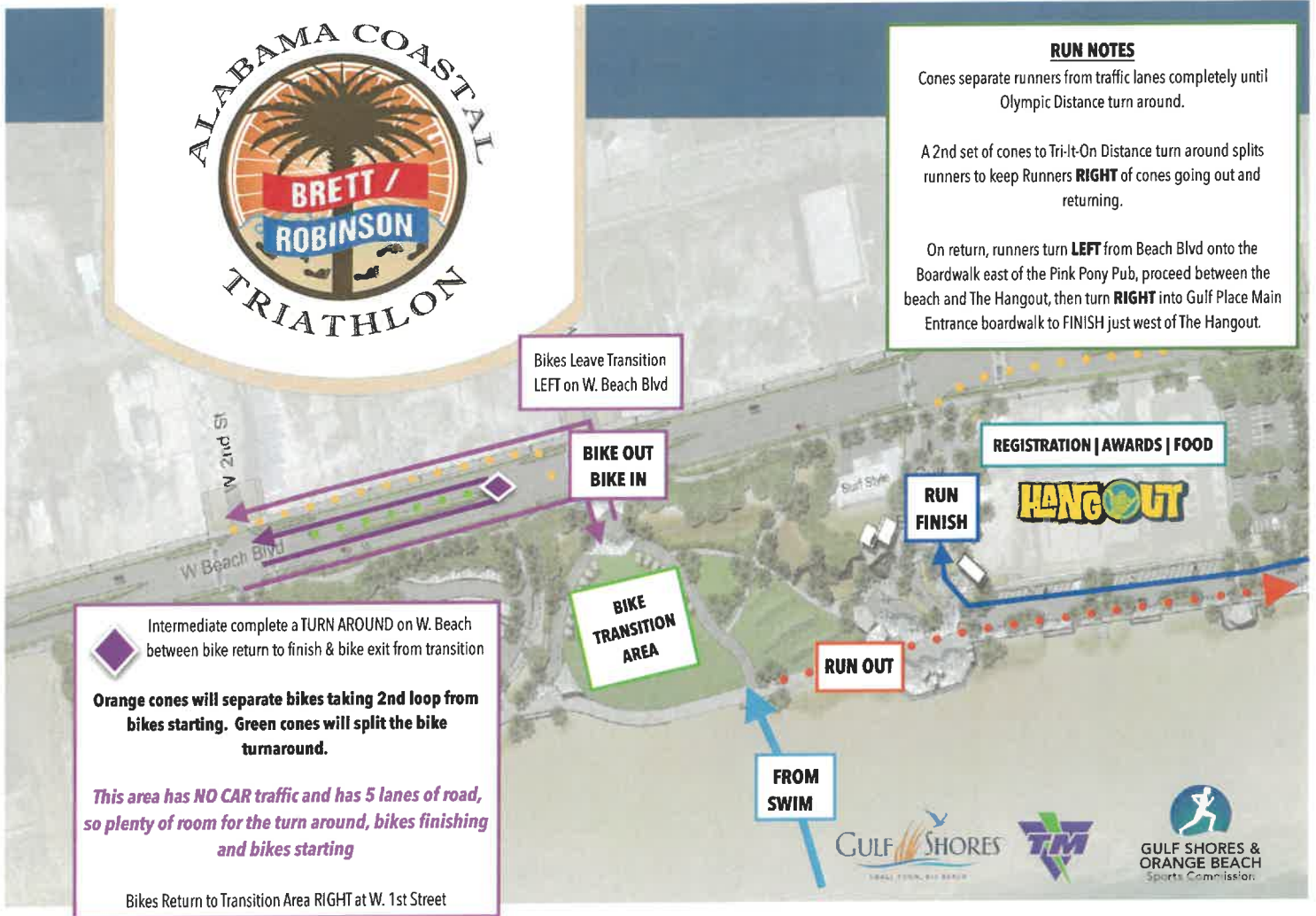

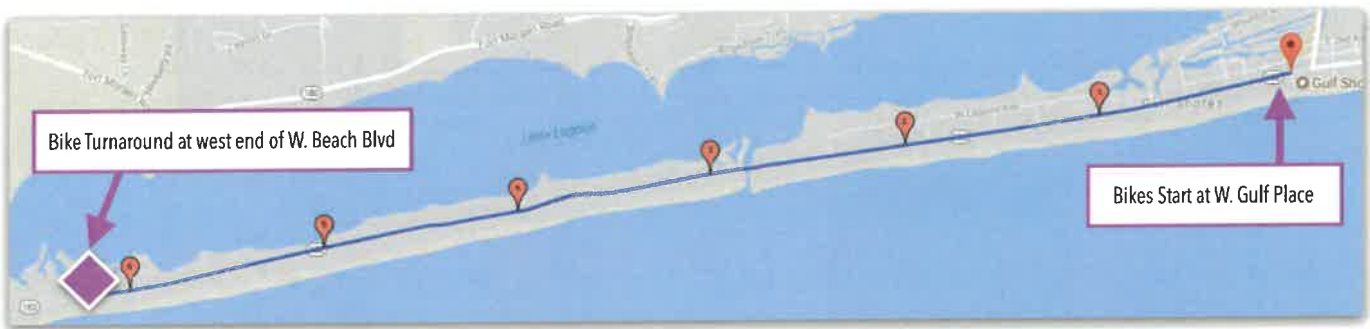

BRETT ROBINSON ALABAMA COASTAL TRIATHLON BIKE COURSE: 40K OLYMPIC & 20K TRI-IT-ON



- Bikes exit W. Gulf Place from the bike transition area (main staging area) on W. Beach Blvd, going west (LEFT)
- Proceed west on W. Beach Blvd. to turnaround just before the road ends at 6.2 miles
- **Tri-It-On** participants do **one out and back loop** only while **Olympic distance** participants will do **two loops**
- When Olympic bikes return from the 1st out and back loop, they will complete a turnaround at W. 1st Street & the Transition Bike Exit, then do the same out and back loop one more time
- As bikes return to the transition area (main staging area) they will turn RIGHT at W. 1st Street from W. Beach Blvd to finish their bike ride, returning their bikes to their assigned bike rack before beginning their run segment



BRETT ROBINSON ALABAMA COASTAL TRIATHLON RUN COURSE: 6 MILE OLYMPIC & 2 MILE TRI-IT-ON



- Runners exit W. Gulf Place heading EAST from the transition area (main staging area) between The Hangout and the beach
- **TRI-IT-ON:** Proceed east on E. Beach Blvd. to turnaround at 1 mile, just after E. 4th Street near Royal Palms Condominium
- **OLYMPIC:** Proceed east on Beach Blvd. continuing to turnaround near 3 miles; before west entrance of Gulf State Park Pavilion
- **When returning to the main staging, runners will turn RIGHT just after THE HANGOUT to the race FINISH LINE**
- The right turn to the race finish is the road just to the west of The Hangout, and the main entrance to the Gulf Shores Public Beach



Runners Leave Transition (east) behind The Hangout toward Orange Beach then use the new boardwalk behind The Pink Pony Pub out to E. Beach Blvd. Runners use the south most lanes, closest to the beach, out and back. **Cones will separate runners from traffic lane.**

Runners return on the BEACH side of The Hangout staying to their RIGHT and turn into finish between The Hangout & the Main Staging Area

STAYING TO YOUR RIGHT OUT AND BACK WILL AVOID HEAD TO HEAD RUNNING TRAFFIC AND ANY CROSSOVER


