**A RESOLUTION
RESCINDING RESOLUTION NO. 6441-21
ACCEPTING THE EQUIPMENT LEASE PROPOSAL OF
JERRY PATE TURF AND IRRIGATION
IN AN AMOUNT NOT TO EXCEED \$253,035.92 FOR
FOUR (4) TORO REELMASTER 3575-D MOWERS
TO NOW PURCHASE SAID MOWERS
IN AN AMOUNT NOT TO EXCEED \$266,416.08**

WHEREAS, that on August 9, 2021, the City Council of the City of Gulf Shores approved Resolution No. 6441-21 approving the lease proposal of Jerry Pate Turf and Irrigation, National IPA Member and State of Alabama Department of Examiners of Public Accounts approved purchasing cooperative, in the amount of \$253,035.92 (\$48,500 per annual lease installment) for four (4) Toro Reelmaster 3575-D mowers; and

WHEREAS, that considerations of purchasing instead of leasing the mowers due to additional financing fees, paying personal property tax on leased equipment of approximately \$38,000, and having no residual value upon the completion of the lease, it's believed it is in the best interest of the City to outright purchase the equipment. The purchase versus lease will not change our extended warranty coverage or service arrangement.

THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GULF SHORES, ALABAMA, WHILE IN REGULAR SESSION ON MARCH 13, 2023, as follows:

Section 1. That the equipment proposal of Jerry Pate Turf and Irrigation, in the amount of \$266,416.08 for four (4) Toro Reelmaster 3575-D mowers, for the Recreation and Cultural Affairs Department be and the same is hereby accepted.

Section 2. That the Mayor and City Clerk be and they are hereby authorized and directed to execute and attest, respectively, a contract between the City of Gulf Shores and Jerry Pate Turf and Irrigation to purchase four (4) Toro Reelmaster 3575-D mowers in substantially the form presented to Council this date.

Section 3. That the purchase price of \$266,416.08 will need to be amended into the 2023 Capital Budget.

Section 4. That the City Council hereby rescinds Resolution No. 6441-21 in its entirety.

Section 5. That this Resolution shall become effective upon its adoption.
